The Board of Directors of the Centerra Metropolitan District No. 2, Larimer County, Colorado, held a meeting via Microsoft Teams on Thursday, November 18, 2021 at 12:00 P.M.

Mr. Abbott stated that proper publication was made to allow the Board to conduct a public hearing on the District's 2022 budget. Director Perry opened the public hearing on the District's proposed 2022 budget. There being no public comment on the District's budget, the public hearing was closed.

Thereupon, Director Perry moved to adopt the following Resolution:

RESOLUTION

A RESOLUTION SUMMARIZING REVENUES AND EXPENDITURES, ADOPTING A BUDGET, SETTING FORTH MILL LEVIES, AND APPROPRIATING SUMS OF MONEY TO THE GENERAL FUND IN THE AMOUNTS AND FOR THE PURPOSES SET FORTH HEREIN FOR THE CENTERRA METROPOLITAN DISTRICT NO. 2, LARIMER COUNTY, COLORADO, FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY 2022, AND ENDING ON THE LAST DAY OF DECEMBER 2022,

WHEREAS, the Board of Directors of the Centerra Metropolitan District No. 2 has authorized its consultants to prepare and submit a proposed budget to said governing body at the proper time; and

WHEREAS, the proposed budget has been submitted to the Board of Directors of the District for its consideration; and

WHEREAS, upon due and proper notice, published on November 2, 2021, in The Loveland Reporter-Herald, a newspaper having general circulation within the boundaries of the District, pursuant to statute, said proposed budget was available for inspection by the public at a designated public office, a public hearing was held on November 18, 2021, and interested electors were given the opportunity to file or register any objections to said proposed budget; and

WHEREAS, whatever increases may have been made in the expenditures, like increases were added to the revenues so that the budget remains in balance, as required by law,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CENTERRA METROPOLITAN DISTRICT NO. 2 OF LARIMER COUNTY, COLORADO:

Section 1. 2022 Budget Revenues. That the estimated revenues for each fund as more specifically set out in the budget attached hereto are accepted and approved.

Section 2. 2022 Budget Expenditures. That the estimated expenditures for each fund as more specifically set out in the budget attached hereto are accepted and approved.

Section 3. Adoption of Budget for 2022. That the budget as submitted and attached hereto and incorporated herein by this reference, and if amended, then as amended, is hereby approved and adopted as the budget of the Centerra Metropolitan District No. 2 for calendar year 2022.

Section 4. 2022 Levy of Property Taxes. That the foregoing budget indicated that the amount of money necessary to balance the budget from property taxes for the 2022 Budget year is \$69,075.32. That the 2021 valuation for assessment, as certified by the Larimer County Assessor, is \$1,323,282.

A. Levy for General Operating Fund. That for the purposes of meeting all general operating expense of the District during the 2022 budget year, there is hereby levied a tax of 0.00 mills upon each dollar of the 2021 total valuation of assessment of all taxable property within the District.

B. Levy for General Obligation Bonds and Interest. That for the purposes of meeting all general obligation bond and interest approved at election of the District during the 2022 budget year, there is hereby levied a tax of 34.214 mills upon each dollar of the 2021 total valuation of assessment of all taxable property within the District; there is hereby levied a tax of 9.108 mills upon each dollar of the 2021 total valuation of assessment of all taxable property within the Bond District #2; there is hereby levied a tax of 24.165 mills upon each dollar of the 2021 total valuation of assessment of all taxable property within the Flats District #2; there is hereby levied a tax of 17.862 mills upon each dollar of the 2021 total valuation of assessment of all taxable property within the Residential Debt District #2; there is hereby levied a tax of 34.734 mills upon each dollar of the 2021 total valuation of assessment of all taxable property within the Railway Flats District #2; there is hereby levied a tax of 31.584 mills upon each dollar of the 2021 total valuation of assessment of all taxable property within the Savanna Fourth District #2.

C. Levy for Contractual Obligations. That for the purposes of meeting all general contractual obligations approved at election of the District during the 2022 budget year, there is hereby levied a tax of 17.986 mills upon each dollar of the 2021 total valuation of assessment of all taxable property within the District.

Section 5. Property Tax and Fiscal Year Spending Limits. That, being fully informed, the Board finds that the foregoing budget and mill levies do not result in a violation of any applicable property tax or fiscal year spending limitation.

Section 6. Certification to County Commissioners. The District's manager is hereby authorized and directed to immediately certify to the County Commissioners of Larimer County, Colorado, the 52.200 for District No. 2, 9.108 for District No. 2 Bond, 24.165 for District No. 2 Flats, 17.862 for District No. 2 Residential Debt, 34.734 for District No. 2 Railway Flats, 31.584 for District No. 2 Savanna Fourth mill levy for the District hereinabove determined and set. 2022 BUDGET MESSAGE

Centerra Metropolitan District No. 2 is a quasi-municipal corporation organized and operated pursuant to provisions set forth in the Colorado Special District Act. The District was established as the “Finance District” as part of a “Multiple District Structure” for the mixed-use development known as “Centerra” located in the City of Loveland, Colorado. Along with its companion Districts No. 1 (“Service District”) and No. 3, No. 4, and No. 5 (“Financing Districts”), this District was organized to provide construction, installation, financing and operation of public improvements, including streets, traffic safety controls, landscaping, water, sanitary sewer, storm drainage, television relay, transportation, and park and recreation facilities.

The District has no employees at this time and all operations and administrative functions are contracted.

The budget is prepared on the modified accrual basis of accounting, which is consistent with the basis of accounting used in presenting the District's financial statements.

The District's strategy in preparing the 2021 budget is to strive to provide the level of services as desired by the constituents of the District in the most economic manner possible.

General Fund

The District adopted a mill levy of 52.200 mills which resulted in budgeted property tax revenue on the assessed value (net of the tax increment) of \$69,075 and specific ownership tax revenue of \$484,158. Certain properties have been excluded from the District but retained an obligation on debt that was issued prior to exclusion. These properties are within Centerra MD No. 2 Bond, Centerra MD No. 2 Res Debt, Centerra MD No. 2 Flats, Centerra MD No. 2 Savanna Fourth, and Centerra MD No. 2 Railway Flats which adopted debt only mill levies of 9.108 mills, 17.862 mills, 24.165 mills, 31.584 mills, and 34.734 mills, respectively. This resulted in budgeted property tax revenue of \$23,168, \$2,084, \$1,476, \$2,000, and \$1,342 respectively, and specific ownership tax of \$25,790 for the purpose of paying debt obligation as discussed below under Debt. With the exception of the County Treasurer fees, all expenditures are related to the transfers to District No. 1 for overall operating costs and debt service as required by intergovernmental agreements. Budgeted expenses total \$629,093.

Debt

The District has no outstanding debt. However, property tax revenues are pledged to the Series 2017, 2018 Bonds, and 2020 Bonds for District No. 1 through a Capital Pledge Agreement.

Reserves

The District transfers all of its revenue to Centerra Metropolitan District No. 1 as provided for in an intergovernmental agreement between Centerra Metropolitan District Nos. 1-5. Therefore, no emergency reserve has been provided for in Centerra Metropolitan District No. 2. The emergency reserve is held by Centerra Metropolitan District No. 1.
